## **Exam**

1. Fill Up PCE & Celli Form OR PCIL  
(depend on IO)
2. Submit to GE
3. After 3 days sign up : <https://www.mii4u.org/ilms/user/login>  
- Get Exam permit & exam result

Note : Compulsary to bring exam permit & IC for seat exam / online exam during MCO

## **After Exam pass**

1. Fill up Agent application Consent
2. Prepare all document needed.
3. Submit online application thru GSM/USM epartner (EAppointment)  
Notes: Need to attach consent form to the system  
- If submit using USM or AM account > need to approve using TLP Account
4. After 2-3 working days, check email for application accepted. 1st email receive is for verification. Sign agent appointment & attach with all document (refer checklist) submit to GE.
5. After 2-3 working days, 2nd email, login then agent activated.

7. After Epartner login, compulsory to do PEP Module 1 & PEP Y1 Training  
(Epartner > Application > **LAMP** > Home > Browse > Browse Catalog > Mandatory Courses - Year 1 Agent )
